In compliance with Sections 108 and 110 of the Act and the rules made there under, the MCA Circulars and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has provided the facility to the members to exercise their votes electronically and vote on the Resolutions through remote e-voting service facility arranged by Central Depository Services (India) Limited ("CDSL").

Pursuant to Rule 22(5) of the Rules, the Board of Directors of the Company have appointed Mr. Akshay Gupta, Proprietor of M/s. Akshay Gupta & Co, Kota, having Membership No. F12960 and CP No. 21448, as the Scrutinizer to conduct the Postal Ballot only through remote e-voting process in a fair and transparent manner.

The Postal Ballot Notice dated March 18, 2025 was sent to Members of the Company whose names appeared on the Register of Members/List of beneficiaries as on March 14, 2025 (Cut Off date). The Company has completed sending Postal Ballot Notices by way of emails on 20th March, 2025 to those members/ shareholders who have registered their e-mail ids with the depositories or with the Company.

The remote e-voting period commences on Saturday, March 22, 2025 at 09:00 A.M. (IST) and ends on Sunday, April 20, 2024 at 05:00 P.M. (IST).

The results shall be declared within 2 working days i.e. Tuesday, April 22, 2025 by posting the same on the website of the Company (www.josts.com), website of CDSL (www.evotingindia.com.) and by filing with BSE Limited (www.bseindia.com) where the equity shares of the Company are listed. It shall also be displayed on the Notice Board at the Registered Office of the Company.

The Company will submit the details of voting results as required under Regulation 44(3) of the SEBI Listing Regulations, along with the Scrutinizer Report separately, in due course.

The Resolutions, if passed by the requisite majority, shall be deemed to have been passed on Sunday, April 20, 2025 i.e. the last date specified for remote e-voting.
