Mere grabbing of breast, breaking pyjama string don't amount to rape: HC

The Allahabad HC has ruled mere grabbing of the breast and breaking of the string of a 'pyjama' do not amount to offence of rape but such offence falls under the ambit of assault or use of criminal force against any woman with the intent to disrobe or compel her to be naked.

The order was passed by Justice Ram Manohar Narayan Mishra on a revision petition by two persons who challenged the order of a Special Judge of Kasganj by which the court summoned them under IPC Section 376 apart from other sections.

According to the case, a plea was moved before the court of Special Judge, Peco Act, alleging at 5pm on

November 10, 2021, she (informant) was returning from the home of her sister-in-law (husbands sister) along with her minor daughter aged about 14 years.

Accused Pawan, Akash and Ashok, who were her village men, met her on the way on a muddy road and asked where she was coming from. She replied she was coming from her sister-in-law's place, Pawan offered a lift to her daughter, assuring he would drop her at her house. She permitted her daughter to accompany him on his bike.

The accused stopped their motorcycle on the muddy way to her village and started grabbing her breasts. Akash dragged her and tried to take her beneath the culvert and broke the string of her pyjama. Two persons reached

the spot on hearing the cries of her daughter. The accused persons threatened them with life by pointing a country-made pistol and fled the place. After recording the statement of the victim and the witnesses, the court summoned the accused for offence of rape.

After going through the materials on record, the court found, "In the present case, the allegation against accused Pawan and Akash is they grabbed the breasts of the victim and Akash tried to bring down the lower garment of the victim and for that purpose, they had broken string of her lower garments and tried to drag her beneath the culvert, but due to intervention of witnesses they left the victim and fled the place of incident."

Delhi court: Law no tool to prolong custody

Bail to man booked for defrauding US national

A Delhi court has granted bail to a man booked in a money laundering case for allegedly defrauding a US national and said law could not be used to "unreasonably" prolong an accused's incarceration without trial.

Special judge Gaurav Rao granted bail to Lakshay Vij, accused of defrauding a US citizen online by inducing her to transfer money from her account through a crypto currency wallet. The judge's March 19 order said the accused had already

spent over five months in custody which was "enough" and any further pre-trial detention would "serve no purpose at all".

The order added, "The law prefers bail over jail and the stringent provisions regarding the grant of bail such as provided under Section 45 (1) (ii) of the PMLA cannot become a tool to be used to incarcerate an accused without trial for an unreasonably long time."

Meanwhile, a Rampur court in UP granted regular bail to 3 members of SP leader Azam Khan's family, including wife and elder son in an enemy property case.
